Washington County moved, and Lamoille County seconded, to approve the agenda as presented. MOTION CARRIED

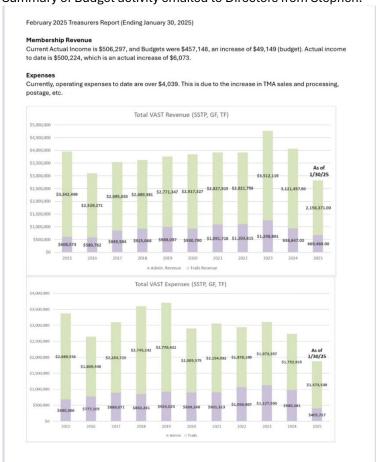
SECRETARY'S REPORT
