Vermont State Police (VSP), Jacob Metayer

4 Classes have turned in the roster.

42 in person participants, missing one roster still.

Online there were 169 participants. for a total of 211.

Jacob wants to make sure interested parties are aware that they would have to pass a record check. Jacob will be sending Cindy a write-up.

## Fish & Wildlife, Jenna Reed

Wardens have been on the trails. Over 100 inspections have been done. At least 20 warnings were issued. The issues that have been brought up are dealer plates. They are not being displayed appropriately, or at all, or being used inappropriately. Tickets will be issued for this. Jenna is sending fine costs for tickets.

The committee would like an off-trail riding video to be shown before a TMA is purchased. It explains the negative effects off-trail riding can create. It will be brought in front of the board.

## SSTP Trail Report, Matt

Woodford, Island Pond, higher elevation trails are doing okay. Other clubs are seeing water on the trails where it hasn't been seen before. It is hoped that when we get a good amount of snow that won't be a problem.
